- **10 full project partners from 4 EU countries – selected ASA WG 3.x leaders and partners (VSB-TUO, EDUCAM, ISCN, APTE, EuroSPI, Transilvania IT, TUG, ASA, ACEA, ITC)**
- Project duration: **January 2023 – December 2024**
- Project budget: 870 004 EUR, **funded 696 003 EUR (80%)**
- Estimated eligible costs **EDUCAM: 72,706€ (±250 days)**

 - **to analyse and pilot forward-looking approaches and methods to enable and make sustainable collaboration on the skills intelligence in the Automotive-Mobility Ecosystem.**

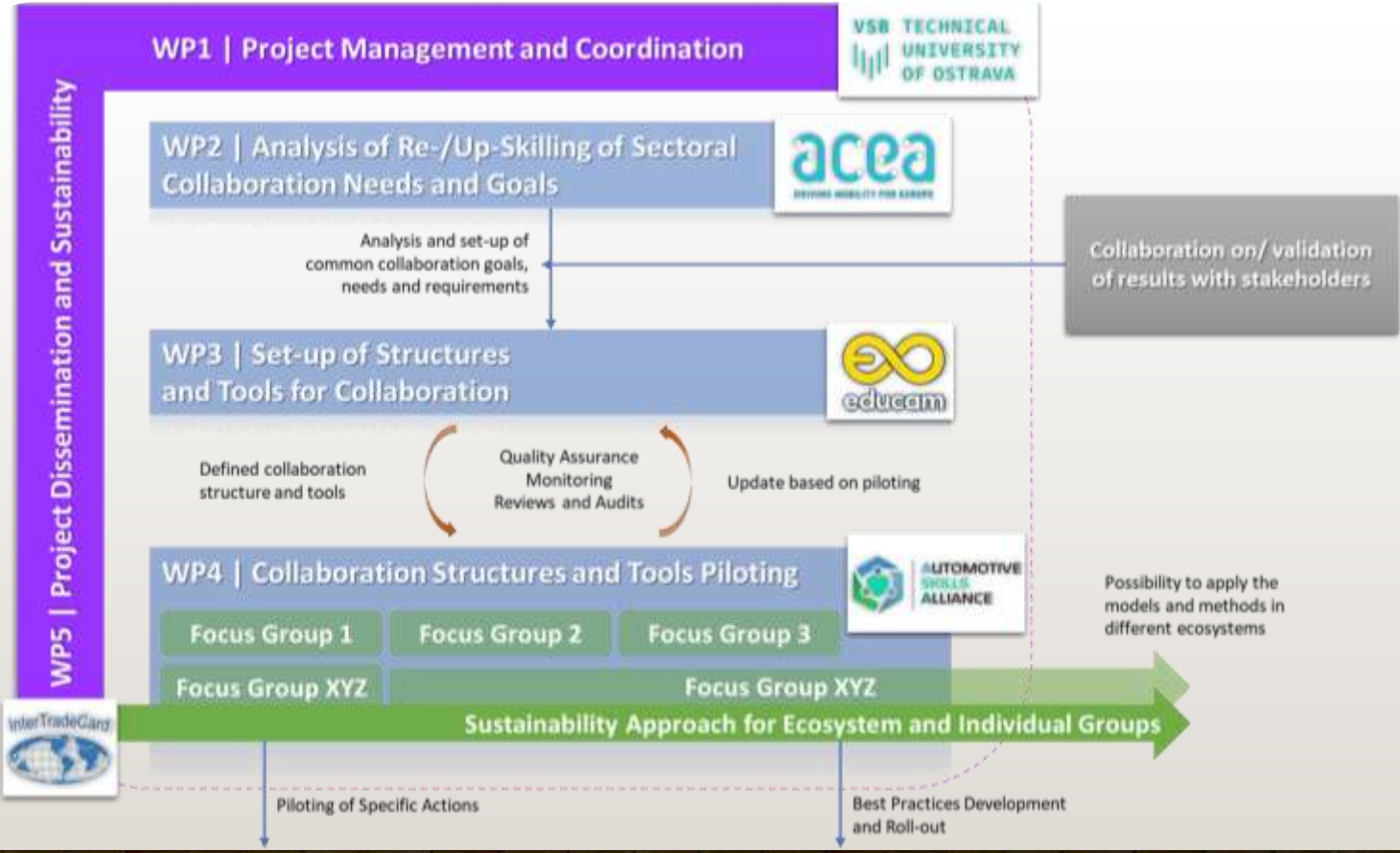
